JENSEN WOODS TENTING POLICIES AND INFORMATION

1. Check-in time is 2:00 p.m. and Check-out time is 12:00 p.m. on the last day of your visit, unless a later time is cleared through the office.
2. Tents are allowed around the treehouses and designated areas.
3. Horses, dogs, and cats are the responsibility of the owner. If another guest is injured by your animal, you are responsible. **All pets must be contained or restrained on a leash of no more than 6 feet, at all times.** Droppings and accidental waste material from pets must be picked up immediately and removed to trash dumpster by Shop. Pets may be left in your unit. Horse manure to be removed to bin by horse stalls.
4. All horses must be kept in a stall when not being ridden, **not at a campsite.** You are allowed to bring your horse to your trailer for saddling.

5. Please keep the area around your tent neat and clean. Keep outside storage of items to a minimum. Trash receptacles are located around the camp for your convenience. Dumpster by Shop.
6. Please observe the 5 MPH speed limit at all times. No ATVs, UTVs or other unlicensed vehicles are allowed on the grounds. Anyone operating a motorized vehicle on the property MUST have a valid driver's license.
7. No alcohol is allowed on the grounds, buildings, or trails.
8. Quiet time is 10:00 p.m. to 7:00 a.m. Please remember that your neighbor may be trying to sleep. Rowdiness, loud music, abusive language, drunkenness, and possession or use of illegal drugs is strictly prohibited.
9. No swimming in the ponds is allowed. Fishing, paddle boat, kayaks and canoes are allowed in fishing pond. Lifejackets are required while using watercraft.
10. No ground fires allowed. Fires must be contained in fire pit and properly extinguished. **Use assigned fire pit.** BBQ grills cannot be used for open fires.
- 11. Parents are responsible for the whereabouts, safety, and conduct of their children, at all times.**
12. All signs, posted notices, and directions of the camp must be obeyed. Non-compliance may result in immediate loss of privileges.
13. The property outside of fences and/or marked by purple paint is private property. Please respect our neighbors' privacy.
14. All federal, state, and local laws must be obeyed at all times.
15. Jensen Woods Camp reserves the right to refuse service or evict anyone in violation of these policies of good camping, for destroying or defacing property and/or creating a disturbance.
16. Jensen Woods Camp is not responsible for fire, theft, injury, or loss of personal property. Guests and all other users of this property are liable for all property damages.
17. Each person using Jensen Woods Camp will sign a liability agreement.
