### JENSEN WOODS BUNK HOUSE POLICIES AND INFORMATION

1. Must provide own towels and bedding.  
Units 1, 2 & 3 have 2 twin bunk beds (4 twin beds).  
Unit 4 has 1 twin bunk bed, 1 bunk with twin on top and full on bottom, and one twin bed. (4 twin and 1 full)
2. Check-in time is 2:00 p.m. and Check-out time is 12:00 p.m. on the last day of your visit, unless a later time is cleared through the office.
3. No pets allowed.
4. Please leave your bunk house swept, clean and trash collected and removed. Dumpster by Shop.

5. Please observe the 5 MPH speed limit at all times. No ATVs, UTVs or other unlicensed vehicles are allowed on the grounds. Anyone operating a motorized vehicle on the property MUST have a valid driver's license.
6. No alcohol is allowed on the grounds, buildings, or trails.
7. Quiet time is 10:00 p.m. to 7:00 a.m. Please remember that your neighbor may be trying to sleep. Rowdiness, loud music, abusive language, drunkenness, and possession or use of illegal drugs is strictly prohibited.
8. The fire ring at the fishing pond worship site may be used. Fires must be contained in enclosed fire pits and extinguished properly.
9. No swimming in the ponds is allowed. Fishing, paddle boat, kayaks and canoes are allowed in fishing pond. Lifejackets are required while using watercraft.
10. The small kitchen in Dixon Lodge may be used at an additional cost.
11. Parents are responsible for the whereabouts, safety, and conduct of their children at all times.
12. All signs, posted notices, and directions of the camp must be obeyed. Non-compliance may result in immediate loss of privileges.
13. The property outside of fences and/or marked by purple paint is private property. Please respect our neighbors' privacy.
14. All federal, state, and local laws must be obeyed at all times.
15. Jensen Woods Camp reserves the right to refuse service or evict anyone in violation of these policies of good camping, for destroying or defacing property and/or creating a disturbance.
16. Jensen Woods Camp is not responsible for fire, theft, injury, or loss of personal property. Guests and all other users of this property are liable for all property damages.
