**\$25.00 Non-refundable Deposit due with this form.** For rentals of \$200.00 or above, a 20% Non-refundable Deposit is due with this form.

Balance of \$\_\_\_\_\_ due on/or before 10 days prior to the event, or within 24 hours if it is less than 10 days prior to the event.

- \$100            Four (4) hours or less including the small kitchen area
- \$200            Full Day, including the small kitchen area
- \$300            Full Day, including the commercial kitchen.

This rental is for the Dixon Lodge and does not give anyone the right to go beyond the Lodge and the immediate lawn area surrounding the Lodge without approval. (There are times when other rental contracts exclude some areas of the camp for use.)

At the conclusion of the event, Dixon Lodge should be swept and cleaned to the same level, or better than, prior to the event. This includes the restrooms.

Trash should be collected and removed to the dumpster by the Shop.

If anything is broken or not functioning properly please advise the Foundation so the matter can be looked into.

The Lessee agrees that it will save, hold, and keep the Foundation and the demised premises free and clear of and from any and all claims, demands, penalties, liability, judgements, costs and expenses, including reasonable attorney fees arising out of any damage which may be sustained by any person or property as a result of the Lessee's use of the Jensen Camp and the Dixon Lodge.

### **JENSEN WOODS POLICIES AND INFORMATION**

1. No pets allowed in any buildings. All pets on property must be on a leash.
2. Please, observe the 5 MPH speed limit, at all times. No ATVs, UTVs or other unlicensed vehicles are allowed on the grounds. Anyone operating a motorized vehicle on the property **MUST** have a valid driver's license.
3. No alcohol is allowed on the grounds, buildings, or trails.
4. Quiet time is 10:00 p.m. to 7:00 a.m. Please remember that your neighbor may be trying to sleep. Rowdiness, loud music, abusive language, drunkenness, and possession or use of illegal drugs is strictly prohibited.
5. No swimming in the ponds is allowed. Fishing in the ponds is allowed.
6. A fire ring at the fishing pond behind the lodge may be used. Bunkhouse lodgers have access to the ring as well. Fires must be contained in enclosed fire pits and extinguished properly.
7. The gazebo to the west of Dixon Lodge may be used but must be shared with any others using the camp unless prior arrangements have been made for private use.
- 8. Parents are responsible for the whereabouts, safety, as well as, conduct of their children, at all times.**
9. All signs, posted notices, and directions of the camp must be obeyed. Non-compliance may result in immediate loss of privileges.

10. The property outside of fences and/or marked by purple paint is private property. Please respect our neighbors' privacy.
11. All federal, state, and local laws will be enforced at all times.
12. Jensen Woods Camp reserves the right to refuse service or evict anyone in violation of these policies of good camping, for destroying or defacing property and/or creating a disturbance.
13. Jensen Woods Camp is not responsible for fire, theft, injury, or loss of personal property. Guests and all other users of this property are liable for all property damages.
